ELVASTON PARISH COUNCIL MINUTES OF THE PARISH COUNCIL MEETING HELD ON 9TH JULY 2012 AT THE VILLAGE HALL, ELVASTON

PUBLIC PARTICIPATION

DISTRICT COUNCILLOR'S REPORT - Neil Atkin

- 1. Cllr Atkin delivered a eulogy in praise of the outgoing clerk.
- 2. The parking notice served on an occupant on Mill Hill, Boulton Moor has been withdrawn now that the occupant has complied.
- 3. A new Standards Committee has been set up at SDDC.
- 4. The Tourist Information Office at Sharpe's Pottery has been voted one of the best in England.
- 5. Unemployment in South Derbyshire has dropped according to latest statistics, helped by the success of a recent jobs fair.
- 6. The new Chairman of SDDC is Cllr Michael Bales who can be contacted on 01283 595721.
- 7. It is alleged that the recent flooding of agricultural land at Repton was caused by the opening of sluices upstream on the River Dove.

COUNTY COUNCILLOR'S REPORT - John Harrison

- 1. Cllr Harrison expressed concern that the Derby Telegraph report of the Environment Agency's consultation on the Lower Derwent flood prevention plans did not make mention of the downstream effects.
- The heavy rain had caused the authorities to monitor the condition of the Elvaston Castle Showground prior to it being used for the Rock & Bike Festival for which people would be assembling on 12th July.
- 3. Cllr Harrison wished the Clerk a long and happy retirement.

OPEN SESSION

- 1. Mr Waters asked permission to speak at the agenda item "Gravel & Flooding".
- 2. Mr Shaw said that difficulty getting to the County Show on foot had been experienced because roadside hedges had not been cut.
- 3. Mr Shaw said that he had been given to understand that the footpath alongside the B5010 was scheduled for widening in October.
- 4. A resident of Orchard Close on Boulton Moor complained about the lack of maintenance on the estate (mowing, hedgecutting, streetlighting)
- 5. Mr Foster (Environment Agency) said that flood bank inspections normally would take place once a year but because of the sensitivity of the issue, the frequency had been doubled. He also said that a replacement inspection cover had been fitted at the head of the Thulston Brook culvert.
- 6. Mr Foster said that a grant of £15,000 had been secured to control silting on a stretch of Thulston Brook.
