
## **ELVASTON CASTLE AND COUNTRY PARK**

## PLANNING APPLICATION CD9/0222/34 NOW PUBLISHED We need YOUR HELP to object to the new ROAD & CAR PARKS – Here's Why:

### The planning application includes:

- a new <u>500</u> space car park with 300 space overspill
- a new access road to the country park from the B5010 (Shardlow Road)
- widening of the B5010 (Shardlow Road) and removal of historic and protected trees in greenbelt
- a new four spur roundabout over 26m in diameter on the B5010 (Shardlow Road)
- infrastructure plans to be funded by Derbyshire tax payers through council funding



#### The impact on existing visitors, Elvaston Castle Country Park and the local community:

Destruction of woodland including Rookery Wood	Less green space
Wildlife habitats lost	Significantly increased pollution
Increased noise levels	Loss of greenbelt
Potential for more construction development	Loss of the rural village identity
Villages at increased risk of flooding	In contravention of climate change policy
Excessive concrete & infrastructure	Historic and protected trees felled
Raised parking fees leading to increased congestion in the villages of Thulston and Elvaston
